Another big accomplishment has been identifying the very high frequency of the Joint Hypermobility Syndrome (JHS) in Chile (40% of the population) and the personal crusade to make this diagnosis accepted and known not only in Chile, but also in other countries, obtaining international recognition for this endeavor.

To be the Co-ordinator for the Joint Hypermobility Syndrome (JHS) Study Group at the ACR in 2007, 2008 and 2009.

My active work as a volunteer of the Arthritis Foundation for 32 years, especially participating in medical and public education.

An important accomplishment was to re-start my medical career in USA, having to pass exams to be able to do private practice and teaching and finally getting to be a Clinical Professor of Medicine (Rheumatology) at the University of Colorado Health Sciences Center.

Another interesting work was to be the Medical Co-ordinator (Academic Rheumatologist) of the Regional Arthritis Program for Colorado and Wyoming, for 2 years, 1974 and 1975.

Together with Professor Charley J Smyth, MD we created the Team Approach for the Treatment of Rheumatic patients, that was a Center for comprehensive treatment of hospitalized rheumatological patients at Rose Memorial Hospital, that for a long time was considered a model for similar establishments throughout the country.

Another important activity has been the creation of my personal rheumatological Web Site www.reumatologia-dr-bravo.cl, which has had to date 58,000, visits, nationally and internationally and has been very well received. Has been a very good way to educate physicians, patients and general public. I have answered thousands of letters from both patients and physicians from all over the world in the last 8 years.

8. Teaching Auto evaluation.

I think that the most important of my teaching activity has been, throughout the years, to teach rheumatological semiology to medical students, residents, fellows and physicians and also developing a very complete rheumatological chart. I have taught dedication, how to listen carefully to the patient, to give them the necessary time, to do a thorough examination, to be gentle and polite, to be up to date in medical knowledge, not to postpone the patients needs for clinical drug studies, to be honest in medical publications and not to be selfish with their knowledge and to be cordial and loyal to their peers.
